Call to Order -

Introductions and Welcome -

RFP feedback and recommendations -

Items for discussion: 1) need to discuss the budget allocation of funds for emphasizing the ISY/OSYsplit. 2) talk about the last RFP process for creating the benchmark for a good response to the RFP. Do we want to continue to prioritize for an ISY program?

Motion was made to discontinue In-School Youth (ISY) programming as of PY14 with provision of continuing to serve current ISY until they could be exited for all six counties by Ms. Kohn and second by Ms. Koch. All were in favor.

Youth contract awards for PY 2013 -

Discussion over the youth contracts had two thought processes: 1) let it roll if we don't exceed the 20% in PY13 into PY14 with the recognition that we will do another RFP. 2) if we can't roll the funds that we would consider splitting the surplus funds to the current PY13 providers. Good discussions over the splitting and amount of funds being considered.

Discussion - In School Youth Future - Action Item

Items for discussion are: 1) need to discuss the budget allocation of funds for emphasizing the In-School and Out-Of-School split. 2) The need to talk about the last RFP process for creating the benchmark for a good response to the RFP. 3) Do we want to continue to prioritize for an In-School Youth (ISY) program?

Recommendation for a motion was made to discontinue ISY programming as of PY14 with a provision of continuing to serve current ISY until they could be exited for all six counties by Ms. Kohn and second by Ms. Koch.
