## Fox Valley Workforce Development Board Releases 2024-2027 Local Plan for Public Comment

The Fox Valley Workforce Development Board, a 501(c)3 not-for-profit based in Neenah with a focus on workforce training and job search assistance, has released its draft Local Workforce Development Plan for the 2024-2027 years. It will remain open for public comment until August 25, 2024.

The Workforce Innovation and Opportunity Act of 2014 (“WIOA”) mandates regional workforce planning as does the State of Wisconsin. Each of the 11 Workforce Development Boards in Wisconsin have drafted a local plan for its specific workforce development activities. In addition to the local plan, the Workforce Development Areas 4 and 5 (Fox Valley and Bay Area Workforce Development Boards) have also completed a regional plan.

The Local Workforce Development Plan for the Fox Valley Workforce Development Area describes how the workforce development system will be implemented in the counties of Calumet, Fond du Lac, Green Lake, Waupaca, Waushara and Winnebago.

The Local Plan will be implemented to assist the FVWDB in meeting its mission of: “Working collaboratively in our communities to create and sustain a fully engaged, talented workforce for tomorrow, and beyond.” Funding for the workforce development system is primarily through the Workforce Innovation and Opportunity Act administered by the United States Department of Labor.

FVWDB operates the Fox Cities Job Center – Menasha, 1802 Appleton Road.
